Purchase Reservation Agreement & Receipt

Thank you for your* interest in Reliable Chevrolet's 2014 Corvette Stingray allocation. In order to reserve a Corvette Stingray in your name, you must deposit \$1,000 with Reliable Chevrolet. This deposit will be made in the form of either Check, Money Order, Cash or Credit Card. Upon receipt in full of the deposit, a copy of this Receipt and Agreement will be provided for your records.

Your deposit is refundable up to the date in which GM / Chevrolet accepts the order to the Vehicle Order Management System (status code 2000). Purchase Reservation will be eligible for refund in the event GM / Chevrolet does not schedule your car for production prior to Dec. 31st, 2013. Each Corvette Stingray is ordered and supplied to customers on a "first come, first served" basis. Reliable Chevrolet will work with you to order from General Motors a Corvette Stingray in your desired configuration. However, no guarantee is made that General Motors will be able to fill your specific order. Your Corvette Stingray order is subject to options availability. This is a binding agreement and you will be required to buy the Corvette Stingray which you order. If GM constraints restrict the ability to order a Corvette Stingray that matches your options and desires when it is your turn to receive a Corvette Stingray, your order will be deferred, and the next-in-line customer will be allowed to place his/her order. If a 2014 Corvette Stingray matching your order can not be built during the time which Reliable Chevrolet orders its 2014 Corvette allocation and no substitute vehicle is acceptable to you, Reliable Chevrolet will refund the full amount of your deposit.

Reliable Chevrolet reserves the right to withdraw your Purchase Reservation at any time at its sole discretion for good cause.** In the event Reliable Chevrolet elects to withdraw your Purchase Reservation, the full amount of your received deposit will be refunded to you within 30 days from the date your reservation is withdrawn. You agree to indemnify and hold harmless, Reliable Chevrolet, Inc., its employees, partners, agents and associates from all claims or causes of action as the result of your Purchase Reservation being withdrawn. Furthermore, you acknowledge, accept and therein waive any rights to claims or causes of action against Reliable Chevrolet, Inc., its employees, partners, agents and associates in the event your order can not be placed and/or manufactured or delivered as the result of any events beyond the control of Reliable Chevrolet, Inc.
